Licensure requirements vary by state as well as the position and title you intend to hold. For example, as reported by the U.S. Bureau of Labor Statistics (BLS, [www.bls.gov](http://www.bls.gov)), a psychologist typically needs to complete a doctoral program, an internship, and up to two years of professional experience to be eligible for licensure.
